



# BLOCK PARTY PERMIT APPLICATION

Written application shall be made to City Hall detailing the location, date and time and the responsible individual(s) for the block party.

Only cul-de-sacs and low-volume streets are eligible to be barricaded for block parties. The Police Department and the Engineering Department jointly determine eligibility to minimize traffic disruption on collector or arterial streets.

The Public Works Department shall deliver barricades on the Friday preceding the weekend of the request (before 4 p.m.); the Public Works Department shall pick up the barricades the following Monday. If party is held other than a weekend, check with City staff on arrangements.

Upon application for the Block Party Permit, the requesting party shall pay a \$35, nonrefundable, administrative fee plus a \$50 deposit. The \$50 deposit will be refunded within two days after the City has repossessed the barricades provided, undamaged.

City Ordinance currently does not permit consumption of alcoholic beverages on public right-of-ways. Consumption of alcohol shall take place only on private property.

Picnic tables may be allowed on the street, but must be placed in a manner that traffic is able to travel around them should the need arise. Barricades are intended to discourage, but not prohibit local traffic.

The person responsible for the block party shall be required to sign a disclaimer to hold the City harmless from any damages and/or injuries that may occur as a result of the party.

Hours shall be limited to daylight hours only.

Any live or recorded music and other noise must be kept at reasonable levels. Upon receipt of a complaint, the Police Department shall issue on warning to turn the volume down. Subsequent complaints will result in an order to eliminate the source of the music altogether and/or to discontinue the party.
